

Ineffective border management systems frequently lead to considerable national, regional and international problems. At the same time, this often makes the legal cross-border transit of people and goods more difficult, which may for example reduce the amount of money obtained in customs duties. With these problems in mind, this is a vital area where governance reforms can have a real impact.

### XII. DEFENSE

There is a lightning fast race going on between the big global players leaving behind smaller countries which may not necessary have the budget to participate on a large scale or are just not invited.

#### **REFORM OF ARMED FORCES:**

Clear separation of policing and military responsibilities, civil oversight and supreme civil command as well as adaptation of the budget and size of the armed forces to reflect their requirements.

- Induction and supervision of disarmament, demobilisation and reintegration (GDR) programmes in post-conflict states.




### XIII. DEFENSE INDUSTRY REFORM



Full development cycle from planning trough realization to testing and presentation of our GLOBAL.AG C.A.T. 4x4






